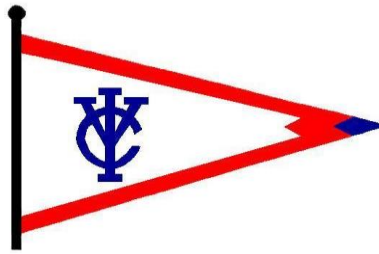

Mission

The object of this Club (IYC) shall be to encourage the sport of Yachting, to promote the science of Seamanship and Navigation and to provide a suitable Club House and Anchorage for the recreation and use of its members.

Classes of Membership

***Senior:** Open but not limited to, boat owners, age thirty (30) and over, who normally moor their vessel in Wilson Harbor, or any owner of a boat 21 ft. (moored or trailered) that is within 20 miles of Wilson. Boat owners under age thirty (30) and non-boat owners may apply for this classification at their option.

* Senior membership requires an initiation fee.

Intermediate: Open to boat owners, age eighteen (18) through twenty nine (29), who normally moor their vessel in Wilson Harbor. Non-boat owners may apply for this classification at their option.

Junior: Open to children age twelve (12) through seventeen (17) who wish to participate in junior sailing programs and whose parents are not members of the Island Yacht Club Inc.

Associate: Open to boat owners who normally moor their vessel in Wilson Harbor but who have previously maintained and are continuing to maintain, in good standing, senior or equivalent membership in any Lake Ontario Yacht Club located within twenty statute miles of Wilson Harbor and to owners of boats under 21 ft. LOA not permanently moored.

Social: Open to individuals other than boat owners who wish to avail themselves of the Club's facilities and social programs. Individuals who own a pontoon style boat or work barge moored in the Wilson harbor, that is used only for transportation, may apply for social membership.

Non-Resident: Open to boat owners who reside and normally moor their vessels more than twenty (20) statute miles from Wilson Harbor. This classification shall also be available to non-boat owners, not electing Social Membership, and who reside over 100 statute miles from Wilson Harbor and who make only infrequent use of the Club.
